# How to calculate your fees?

School fees depend on:

- Your child's year level
- The number of children you have enrolled
- Subjects chosen from Year 9 onwards

There is no fixed fee per child; costs vary based on these factors.

To calculate your annual or term fees:

1. Find your family fee on page 3.
2. Add any student and subject levies listed on pages 4-10
3. The total is the amount payable for the year or term.

## **Example:**

One Child in Year 7

- \$2,840.00 (tuition)
- \$890.00 (capital levy)
- \$500.00 (e-Learning)
- \$750.00 (student levy)
- \$445.00 (camp)

Total Annual Fees: \$5,425.00

One child in Year 8 and a child in Year 10 doing Early Childhood Studies and Fitness Studies

Fees and Levies are emailed to the account holders on a Term basis. This usually occurs within the first three weeks of each term. Payment is due 14 days from the date issued.

**Tuition Fees:** Fees collected are aligned to the Vision and Mission of the College. They are used provide teaching, administrative, classroom support and facilities, assist with providing activities, support the College building program and to maintain buildings, grounds and other facilities.

**Capital Levy:** The Capital Levy is compulsory to ensure our College Redevelopment Programme (Masterplan) continues to remain viable. It is not Tax Deductible.

**Fee Collection Policy:**  
Under College Pastoral Board Policy, we have the option to consider Debt Collection if fees remain outstanding more than three (3) School Terms. The only exception that the College normally makes is where there is an ongoing payment arrangement.

# FEE/LEVY INFORMATION

## Enrolment Fee:

A \$200 payment is payable upon your acceptance of the College Enrolment Offer.

\$100 is a non-refundable administration fee. The remaining \$100 is retained as a fully refundable bond when your child departs the College provided all books, electronic resources and team sports uniforms are returned and a minimum of one term's attendance at the College is completed.

**Camps and retreat** fees will be charged to your account and will appear on the fee statement for the term in which the camp or retreat occurs.

Attendance is compulsory for all students. Should a student be unable to attend a refund may be sought. The College must receive a request in writing within 3 weeks of the event along with a Doctor's Certificate if your student was ill. A NON-REFUNDABLE Administration Fee is applied to each camp, retreat and student activity due to costs incurred by the College for paid deposits, bus bookings, venues and other overheads.

**e-Learning Levy** enables the College to continue to provide cutting edge technology and support for students both personally and in classrooms.

## Library Fund:

Families are invited to contribute to the College Library Fund. This voluntary contribution is receipted separately and is Tax Deductible. The paid amount does not appear on your statement.

## Book Hire Scheme:

The College accesses the bulk payment option of the State Government Textbook and Resource Allowance. Textbook hire is included with the Student Services Levy for both print books and access to digital resources. Students are issued with the resources at the commencement of the school year. Full replacement cost will be expected for any damage, loss or theft of these resources.

## Certificate Courses:

Students who undertake approved certificate (VET) courses are eligible for a 50% discount on the cost of a second or additional VET subject.

This discount will be applied as a credit to Term 4 Tuition Fees. For example:

- A \$1,200 course will receive a \$600 credit.
- A \$300 course will receive a \$150 credit.

To qualify, the course must either be listed in the Subject Selection Handbook, or Receive prior approval from the Principal.

Additionally, the student must complete the course and achieve a passing result. Credits will only be applied once these conditions are met.

## FisherOne and Distance Education:

Students enrolled in subjects through FisherOne or Distance Education will also receive a 50% reimbursement upon successful course completion.

This reimbursement will be issued as a credit to Term 4 Tuition Fees.

### **Fees Concession Policy:**

Where a parent/guardian believes financial circumstances have arisen that will prevent or delay the payment of the school fee account, a concession application is available. A compassionate and just approach under the mission and values of Brisbane Catholic Education and St Patrick's College is used when reviewing applications. The same process is adopted by all Brisbane Catholic Education Colleges for assessing eligibility.

Concession application forms are available on the Parent Portal or from the College office.

Confidentiality of information is guaranteed. Information is only handled by the Principal and Business Manager.

Parents or guardians requesting concessions must provide evidence of gross income, tax and housing costs. Payslips and Centrelink statements are acceptable proof of income, and rental receipts, bank statements and rates notices are evidence of housing costs.

Where the Business Manager and Principal are satisfied with the documentary evidence provided, a concession may be granted without an interview.

No allowance is made for repayments on items such as holiday houses, luxury cars, investment houses, pools and the like.

Once a fee concession is granted it is essential that this commitment is honoured in full and on time. Our preferred method of payment for concession families is Direct Debit. If family circumstances change the College must be informed.

Unless prior arrangements are made the College expects that agreed fees will be paid by the due date. If there is a problem in meeting this provision, a letter of explanation should be sent to the Principal or Business Manager.

**New Fee Concession arrangements need to be negotiated each school year.**

### **Payment Options:**

EFTPOS facilities at the College office

Credit Card payments through Qkr!

Direct Debit payment is available free of charge through the College that allows you to spread the cost of fees over the year. An amount is debited from your account each week, fortnight, month or term. The Direct Debit form can be downloaded from the Parent Portal and are available from the College office. Bank Fees may be charged if a Direct Debit is rejected by your bank.

BPay is available and details of Biller Code and Reference appear on Fee Statements (minimum payment accepted is \$50.00).

.Qkr! is available for Canteen, Uniform Shop, Excursions, Extra-Curricular Activities and other selected payments. These will be advertised during the year on the Parent Portal and College Newsletter. Information may sometimes be available via Facebook – My St Patrick's College
